We require 10% down and taxes paid by you, loan forms completed, a credit report and CARFAX. The same low rates apply to all. Current used car rates are 5.75% for 3 years, 6.25% for 4 years, and 6.75% for 5 years. There is no application fee. Compare our monthly payments to the "0%" payments quoted by the dealers! FIGHTING THE THREAT OF FRAUD

While H&E has experienced NO data breaches, hacking of major retailers can result in new types of fraud for consumers. Criminals can acquire some aspects of personal information which they will use, keeping real identifiers but changing some to apply for credit cards or cell phone service. They can use this information to access your current cards or impersonate you when dealing with accounts. They also may open new accounts and build good credit, then take large loans in your name. This is known as "Synthetic Identity Fraud". You can fight this type of crime.

- Monitor your credit and debit cards closely. Follow accounts online.
- Check your credit reports for signs of fraud. Get free credit reports at www.annualcreditreport.com.
- Pay attention to reports of companies that have been hacked which may have some of your personal information.
- Set up a personal password with your bank or credit union.

H&E and VISA use fraud monitoring programs that alert us to abnormal spending which helps block fraudulent transactions. We, or VISA, will let you know if we see unusual activity, and your card may be automatically restricted. Notify us immediately if you see suspect activity!

you in the event of suspicious Activity. Please answer!

- Checks are now clearing SAME
 DAY— there is no longer ANY
 float time! Be sure you have
 sufficient funds to clear checks
 you write!!
- HAS YOUR BENEFICIARY CHANGED? If you were married, divorced, or had children, please call for a new card!

Debit Card Updates:

If you ask to remove a "block" on a known fraud area and your card is compromised you may not

recover funds. Remove at your own risk!



VACATION TIME TIPS!

.IF YOU ARE GOING OUT OF THE COUNTRY OR STATE— call AHEAD to confirm that your VISA Debit card will be activated in that area! Certain countries and areas are BLOCKED for security.

HOLIDAY LOANS ARE AVAILABLE! Our popular Holiday Loans up to \$2000 for one year at 8% can buy plane tickets, hotel rooms, shore rental! VISA DEBIT CARD USE for hotels or car rentals can result in a large dollar hold on your checking IMMEDIATELY.
